Asana® will be distributed through Valent U.S.A. Corporation, a wholly owned subsidiary of Sumitomo Chemical in the United States. The transaction is subject to approvals from applicable regulatory authorities. Financial terms of the agreement were not disclosed.

Asana® has more than 50 crops on the product label. The active ingredient esfenvalerate, a resolved pyrethroid, was invented by Sumitomo Chemical, and it is currently commercialized in more than 60 countries. In the United States, Asana® was developed and commercialized by DuPont, providing consistent control in U.S. crop production for many years.
